ALL FACE VENEERS SHALL BE MATCHED FOR COLOR AND GRAIN TO PRESENT A UNIFORM APPEARANCE. WHEN BACK VENEERS ARE DIFFERENT SPECIES THAN FACE, THEY SHALL BE OF THE SAME DENSITY AND THICKNESS.

硬木胶合板应当构造的要求 CS-35-56 商业标准。面板应热板，尿素树脂或平等的胶水，束缚 II 型或更好。的脸贴面板喷砂前不得低于 1/28, 应当旋切，切或半圆桦树暴露面板。所有的脸贴面板应匹配颜色和颗粒呈现一个统一的外观。当比脸贴面板是不同的物种，他们应当的相同的密度和厚度。

10. HIGH PRESSURE LAMINATED PLASTIC FACE SHALL HAVE 40-POUND DENSITY PARTICLEBOARD OR APPROVED EQUAL CORE. BACKING SHEET OR UNDERSIDE TO BE 0.03 PLASTIC BACKING SHEET. GLUE USED SHALL BE UREA RESIN OR EQUAL, TO PROVIDE FOR TYPE II BONDAGE, ACCORDING TO THE REQUIREMENTS OF CS-35-56. ALL TOPS AND SIDES OF CASE GOODS ARE TO BE IN 1/16" LAMINATE.

高压层压塑料板 40 磅密度刨花板或者同等的板材。支持表或底部 0.03 塑料表支持。胶水使用脲醛树脂或者相同的情况下，为 II 型束缚，根据 CS-35-56 的要求。所有顶部和侧面的货物要在 1/16" 层压板。

11. JOINTS SHALL BE EITHER SPLINTED, MORTISED AND TENDONED, TONGUED OR DOWELED, OR FULL LENGTH BLOCKED, GLUED AND SCREWED IN TWO DIRECTIONS, FOLLOWING THE BEST PRACTICE OF CONSTRUCTION. ALL JOINTS SHALL BE SET UP FOR PERFECT GLUING. ALL WORK SHALL BE CAREFULLY CORNER BLOCKED, WELL FITTED, GLUED AND REINFORCED WITH WOOD SCREWS. JOINT GLUE SHALL BE OF THE BEST QUALITY HIDE GLUE.

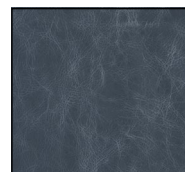

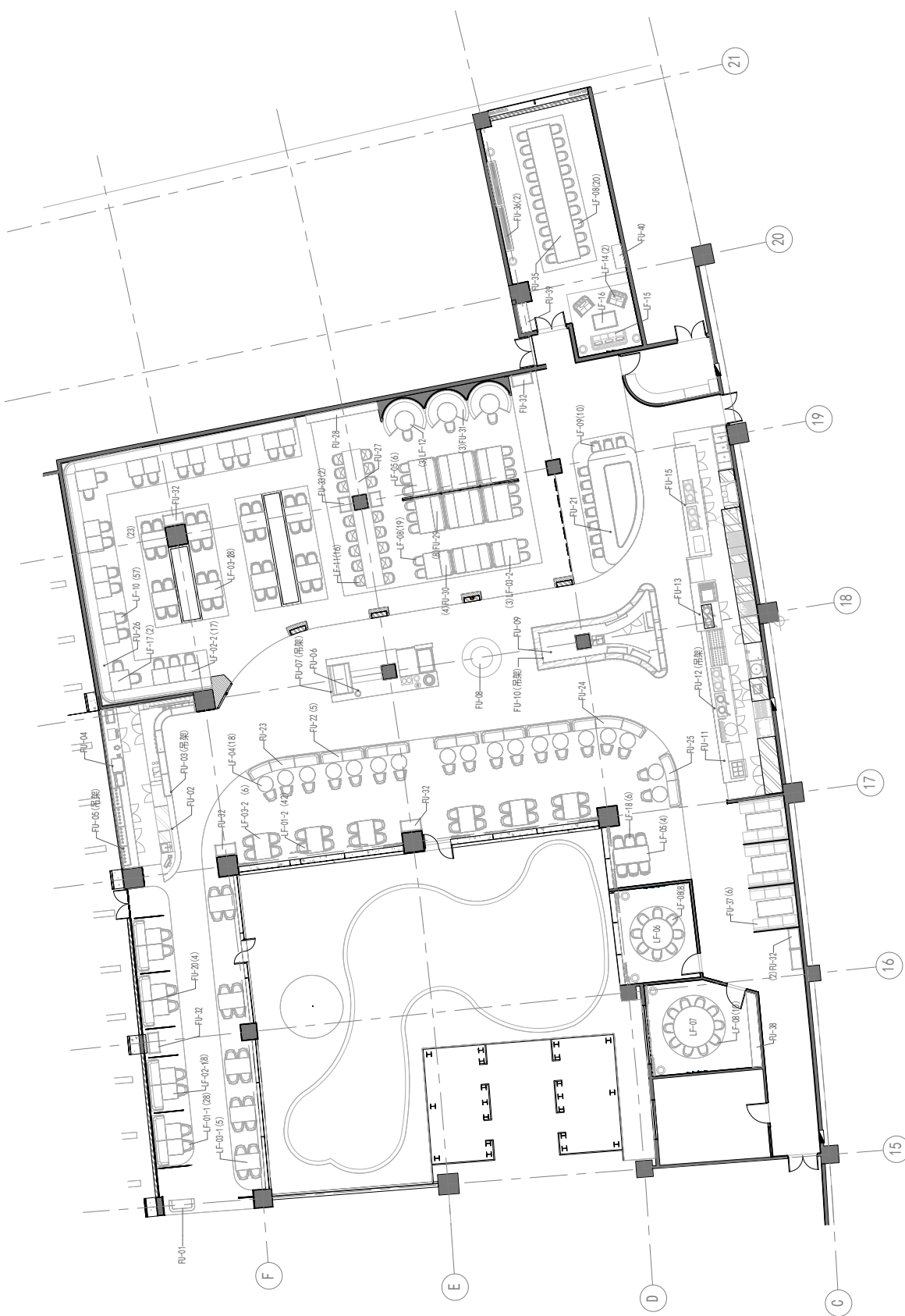
